TIVERTONAND TILSTONE FEARNALL PARISH COUNCIL

Minutes of the Parish Council Meeting held on Tuesday 12 January 2010 at Tiverton Village Hall, commencing at 7.30pm.

Present:

Parish Councillors Farrall (Chairman), Ibbotson (Vice Chairman), Byrd, Cheshire and Wright. Parish Clerk. Cheshire West and Chester (CWAC) Council Member Ritchie. 3 Members of the Public.

Open Forum: Comment was made that a number of Property Owners do not appear to have fully complied with the conditions attached to Planning Permission Grants. The properties in question are i). Hilly Bank, Huxley Lane, Tiverton, ii). 2 Townfield Lane, Tiverton and iii). Stone Cottage, Huxley Lane, Tiverton. **Action Point 1** – **Parish Clerk to refer the three properties to Les Smith, Enforcement Officer at CWAC.**

Roger Blake commented that a number of potholes have appeared in Huxley Lane in recent weeks – he will report these to CWAC via the Web Site Fault Report Facility. CWAC Cllr. Ritchie confirmed that Potholes will be repaired by CWAC as and when they are reported.

CWAC Cllr. Ritchie confirmed that main routes will continue to be given priority with regard to gritting. It was suggested that Cribb Lane and Red Hill be added to the primary route list. **Action Point 2 – Cllr. Cheshire to write to CWAC Highways as appropriate.**

CWAC Cllr. Ritchie apologised for the fact that not all households received a bin tag advising collection dates over the Christmas Holiday period. This was due to unofficial industrial action by a small number of collection crews.

- **1. Apologies for Absence:** Apologies were received from Cllr. Evans and CWAC Members Jones and Wright.
- **2. Declarations of Interest:** There were no Declarations of Interest made.
- **3. Minutes of the Meeting held on Tuesday 17 November 2009:** The Minutes were unanimously approved (Proposed by Cllr. Ibbotson and Seconded by Cllr. Wright) and signed by the Chairman as a true record.
- **4. Matters Arising:** Beeston Castle Hotel Marquee Events The Parish Clerk advised that the issue has been raised with CWAC, who have confirmed that there is currently no Planning Permission in place for the erection of a Marquee on the Pub

Car Park. CWAC commented that they would write to the Pub Owners confirming this position.

<u>Proposed Erection of Village Sign</u> – Cllr. Cheshire advised that ideas are required for the design of the sign. A request for ideas is to be included in the next Village Newsletter. **Action Point 3** – **Cllr. Cheshire to provide an update at the next Parish Council Meeting.**

<u>Village Entry Signs</u> – Cllr. Cheshire advised that the location and styling of the signs has been agreed with Jamie Barron at CWAC. Timing of installation is yet to be advised. **Action Point 4** – **Cllr. Cheshire to provide an update at the next Parish Council Meeting.**

Earlier Meeting with Nicola McKeand from CWAC regarding Local Service Issues — The Parish Clerk confirmed that CWAC have agreed to continue funding Street Orderly Salaries and Churchyard Maintenance throughout 2010/2011. Further information is promised relating to administrative support and block Insurance Cover, once further consideration has been given by the CWAC Executive. **Action Point 5**—**Parish Clerk to remain in contact with Miss McKeand.**

<u>Land Adjacent to Lodge Lane</u> – CWAC have confirmed that they will check the reopened access point. However, they comment that as it is an existing access with unchanged use, and it has no accident history, they are not in a position to enforce closure.

Ongoing Damage to Lorry Turning Circle – CWAC undertook a site visit on 22 December 2009 with a view to agreeing a programme of structural changes to the entrance/exit points. The intention is to undertake the work early in 2010. The need for Parish Council input into the proposed realignment of the entrance/exit points, and the provision of more informative signage, was agreed. CWAC Cllr. Ritchie will ask Gareth Hansom at CWAC to ensure that the Parish Council is involved throughout the initial evaluation process. Action Point 6 – Parish Clerk to provide an update at the next Parish Council Meeting.

<u>Electoral Boundaries</u> – Since the last meeting the Boundaries Commission has published its' draft proposals for the new Ward Structure in CWAC. After discussion, including input from CWAC Cllr. Ritchie and Doug Haynes (Clerk to Beeston Parish Council), it was agreed to write to both the Boundaries Commission and CWAC confirming the Parish Councils' support for the creation of a Tattenhall Ward represented by one Councillor. **Action Point 7** – **Cllr. Ibbotson to write to both the Boundaries Commission and CWAC.**

- **5. Homewatch and Police Report:** Roger Blake advised that there were no issues to report. Copies of recent Homewatch Bulletins are held on file.
