

TIVERTON & TILSTONE FEARNALL PARISH COUNCIL

Minutes of Tiverton & Tilstone Fearnall Parish Meeting held in the Village Hall, Tiverton, Cheshire on 22nd November 2005.

APOLOGIES:- Councillor Brewin, Councillor Farrell

OPEN FORUM:-

Burglary in Tiverton, and another incident involving a suspicious caller have raised concerns. Residents asked to remain vigilant, and to ensure Home Watch network informs residents.

Concerns raised by Bridge Club regarding the short piece of road from the village hall to the lay by. Request for further lighting. Suggested members use torches to light the road and be seen. Flashing light on time switch suggested; advice to be sought from Highways Dept as to what low level lighting options available.

Questions also raised again about lighting on A49, and the wildlife surveys mentioned in the Action Plan. Reiterated the Action plan is a suggestion for action, and further investigations will be carried out.

MINUTES OF THE MEETING HELD ON 13th September 2005. It was RESOLVED to approve the minutes of the meeting held 13th September as a correct record.

MATTERS ARISING: No matters arising for discussion as all agenda items.

REVIEW OF CLERKS POSITION: R Cheshire dealing with correspondence as acting clerk. No responses to 'posters' placed in village. Agreed adverts to be placed in Sandstone News and Tarporley Talk.

UPDATE ON PARISH PLAN

Cllr Scott attended Rural South Area Cttee to give a presentation about the Plan.

Parish Plan Account now to be finalised. Summary of Grant monies:

Received £3,688.35 (including Parish council Contribution of £33 3.60). Amount spent £3,366.30. Community Futures (now administering the Countryside Grant) require repayment of £399.00. Overspend on grant monies of £76.95, and arising from recent promotion of the Plan, to be allocated to Parish Plan Development Grant. Repayment of £399 unanimously agreed.

ACTION GROUPS:

PLANNING:

Recent decisions outlined. R Blake thanked the Parish council for their recent support. Thanks also given to City Cllr Haynes who has given much support.

Conservation Area considered. Cllr Pilgrem to follow up with Planning Dept what further information required by them.

Cllr Pilgrem reported the Tree Preservation Orders that have been issued on trees at 2 Townfield Lane. Orders last for 6 months. Issue raised that similar orders lifted after building work completed in Tilstone Fear all.

Discussion of recent meeting with Angela Loftus; notes of meeting circulated. Main concern where the Parish Plan fits into the planning process? Consideration to be given to undertaking Village Design Statement. Cllr Evans to make further enquiries with Angela Loftus, and to put together planning guidelines.

TRANSPORT GROUP: Meeting fixed for 2nd December at The Old Smithy with Fil Prevc of Cheshire County Council and transport officers. City Cllr Haynes to attend with Cllrs Scott, Pilgrem and Evans

ROAD SAFETY :Cllr Pilgrem reported that the Set the Pace information would be included in the next Parish News. Mobile Speed Unit to be available January 2006 – volunteers needed.

HOME WATCH: Incidents as previously reported.

VILLAGE /COMMUNTIY GROUP

A Meeting took place on 25th October involving a number of residents interested in the Village Society. Hazel Wrightson willing to look after the accounts. The society will gradually evolve, but will work by funding /assisting individual events that residents wish to put on.

Cllr Scott has asked Mr Gardiner of St Judes PCC to ask if a notice board can be positioned adjacent to the church board. He is yet to report back. The Parish council to look into funding. County Cllr Moore Dutton stated that notice boards should include postcodes to enable emergency service to identify the location if they are called out to a public place.

Carol Concert suggested in Methodist Chapel 21st December 2005. Cllr Scott to make arrangements for music and carols. Notice to go in parish news.

ACCOUNTS: Accepted and approved, and signed by E Scott and R Cheshire
Guidance suggests precept for next year to be increased by 2.95%. Discussed and agreed by all.

CORRESPONDENCE –Rural South Area Committee Meeting 24th November – Cllr Scott and Povall to attend. The Key (summer edition) – contains information about grants for war memorials and waterways Trust.
