### Chairman's Notes

Since the last Newsletter in June there have been two Parish Council Meetings (in July and September), but very little local news.

It has been a relatively quiet period over the last few months, but two events are worth highlighting. Firstly, the Beeston, Tiverton & Tilstone Fearnall Neighbourhood Development Plan is now complete and will be going to referendum on 30th November. Please make the effort to vote and approve this. An awful lot of effort – especially by Cllr Cheshire - has gone into producing this document and it is important that the Parish gives it the overwhelming approval it deserves.

Secondly there have been a number of incidents reported, relating to damage to property and the grass verges facing onto Huxley Lane. Whilst the actual cause of the property damage cannot be proven, the damage to the grass verges has been caused by large tractors going onto the verge to avoid oncoming vehicles. Having spoken to local farmers it would appear that the situation is quite complex in that many of these tractors belong to farms outside the parish. Concerns have also been expressed regarding the speed of some of these tractors through the village with resultant danger to pedestrians, the noise nuisance for people living in houses close to the road and damage to road surfaces.

A meeting was requested with Ms Helena Crawford of Cheshire Highways Department and set up at very short notice for 10am on 31<sup>st</sup> October at Tiverton Village Hall. I tried as far as possible to invite people who had voiced their concerns about the points above to the meeting and we had a good turnout of about 15 people including several farmers. I apologise to those people who were not made aware of this meeting but I was keen to take the opportunity when it was offered.

All the issues were thoroughly discussed and, on the core "tractor issue", there was much understanding and recognition of the problems on both sides of the argument. For the future a lot depends on more-considerate behaviour by both tractor drivers and the public. We live in an area that has been dairy-farmed from earliest times when both farms and our villages were much smaller and horse-drawn transport and then much smaller tractors prevailed. It was agreed that we would work with local farmers to see if we can identify a way to address the concerns of the public.

On the issue of potholes (or for that matter any highways related issue) we were advised to report them via the CWaC Highways Reporting system: <u>https://maps.cheshirewestandchester.gov.uk/cwac/faultreporting/</u> or if you prefer call 030 123 7036. Anyone can do this, it doesn't have to be a member of the Parish Council, although the Parish Clerk will assist with this if required. One specific large pothole on Huxley Lane near the Chestnut Tree was highlighted and Ms Crawford agreed to look into this as a priority.

With regard to damage to grass verges we were advised that the CWaC would consider, where damage was significant, installing plastic posts onto the grass verge. Individuals were warned against putting their own defences up; for example, rocks or wooden posts, as the householder would be liable for any damage caused to vehicles or for that matter individuals. Further painting of white lines to highlight the edge of the road was also discussed and will be considered by Highways.

Speed calming on Huxley Lane was also discussed. For speed calming measures to be introduced it will be necessary to have sufficient evidence from the Community Speedwatch Team that there is a significant issue.

It was clear that Highways are constrained by regulations and funding and even some of the very limited improvements that Highways have indicated might be possible may need partial funding from the public or the Parish Council.

We will however continue to work with Highways to address the concerns of our parishioners regarding road issues in the parish. Watch this space!

#### **Boundary Changes**

I am sure you have all avidly followed the Boundary Commission proposals and associated public consultation regarding changes to both Ward and Parliamentary Constituency boundaries. But, in case you have not, here is a quick summary. Tattenhall Ward will keep virtually the same boundaries and its single councillor – there was a proposal to revert to 3 or maybe 2 councillors to improve accessibility, but that was rejected.

The original proposal for parliamentary constituencies was to split the area covered by the present Eddisbury and Weaver Vale constituencies into two long South West to North East constituencies, but with the Western one strangely named Weaver Vale and the Eastern one named Eddisbury and Northwich. So, we would be in Weaver Vale, along with much of Delamere Forest, Frodsham and Daresbury. However, after public objections the latest proposals have reverted to the old North-South split with boundaries only marginally changed from the current ones, chopping off bits near Chester and bigger chunks near Crewe and Nantwich.

The main objective of all this is to ensure that wards and constituencies respectively are all of a similar size in terms of electorate (in the case of constituencies between 71,031 and 78,507 i.e. 74,769 plus or minus 5%). In addition, the number of constituencies is being reduced from 650 to 600.
