Chairman's Letter

Thank you to all who attended our celebration and launch evening for the Parish Plan - it was encouraging to see such a good turn out for Mike Wellman's presentation. Mike is someone certainly worth listening to, and we look forward to working with him in the future.

Carrying out the Action Plan is a long term vision, but we have already started to see how it can be implemented.

We have met with the Principal Planning Officer to explore our planning and development aims, to raise the issue of the need for us to be properly consulted on planning applications, and to get better understanding how the Plan can be incorporated into the planning process.

Transport officers from Cheshire County Council also visited us to discuss what our Plan had to say on rural transport. The point was stressed that we need them to listen to our views, so that we can work together to reach sensible decisions about what services can be provided for us. In the light of our meeting, we have agreed some immediate steps that County will now progress on our behalf.

Within this Parish news you will also read about the anti speeding strategy, following on from the many concerns raised by residents in the survey.

All of these are evolving issues, which will take time to bear results. We will keep you updated, but you can of course obtain further information from the Parish Council minutes which are posted on the notice board, or on our website.

Following a recent incident in Tiverton, I would urge you to remain vigilant, and report anything suspicious that you see. If you do not know who is your local home watch co-ordinator, then please speak to myself, or Roger Blake. Let us discourage these opportunistic thieves by ensuring that valuables are not on display, keeping doors and windows securely locked and ensuring that the entrance to homes is lit so that visitors can be seen. Thieves prefer to operate where they can not be seen.

We have some credit card sized fold out leaflets 'How to get help and advice

from Cheshire Police'. This contains useful police and other service contact information so that you can quickly find the right people to solve your problem. We are distributing these to as many households as we can. If you do not receive one with this Parish News, but would like a copy, please let me know and we will endeavour to obtain more copies from Project Rural Matters.

Anti-Speeding Campaign

The recently published Parish Plan highlighted that speeding is a major concern to parish residents. In response the Parish Council have agreed an antispeeding strategy that is deigned to tackle this important issue.

With this newsletter you should receive a 'Set The Pace - Make the Commitment' information booklet.

This initiative is supported by Cheshire County Council and is intended to help spread the message that the problem of excessive speeds in our communities can be reduced by making a conscious effort to be more speed aware when we use the roads. While people may think that this initiative is 'preaching to the converted', it gives us the opportunity as a community to collectively demonstrate that we take this issue seriously.

We would ask you to read the brochure, and 'Make the Commitment' by returning the enclosed form.

The second step of the anti-speeding strategy will be the use of mobile speed warning signs, these were used as recently as September on Huxley Lane by the Cheshire Constabulary. We also plan to initially site the unit within the 30mph limit on Huxley Lane.

We plan to use the warning signs at various times during a one week period, and need volunteers to help man these units - if you are able to help for a few hours please contact Bob Pilgrem 730955 for details of how you can help.

Highlights from Parish Council Meeting 22 Nov

In previous issues we have advised residents of the value in having a house name visible from the road to make it easier for emergency serivces to find your home. We have now been advised that adding your postcode to the house name sign will also help in providing a speedier response to an emergency.

The Council is seeking to move ahead with a Village Design Statement to supplement the Parish Plan. Peter Evans (732378) has agreed to become the lead Parish Councillor for this endeavour and would like to hear from any parishioners interested in supporting this activity.

The Parish Plan seeks to rationalise the boundaries of the conservaton area in Tiverton. This is a long term issue but it in exploring it, we learn that there are obligations for properties within a conservation area that include the need for permission when thinking about cutting down any established trees.
