There had been a little bit of hope that the November Parish Council meeting could have been held in Tiverton Village Hall once again, but alas rising numbers and new restrictions put paid to that. The next meeting is in January and I

expect that to be via Zoom once again which, as I have said in previous Newsletters, has been really quite effective.

New Parish Councillor

I am pleased to announce that we have a new Parish Councillor – Lesley Randles. Speed Limit Change by Four Lane Ends

Those of you who have been following this drama will be aware that the Parish Council has been lobbying for a reduction in the speed limit at Four Lane Ends, formerly known as the Red Fox Junction, for many years. All hoops have been jumped through and all boxes have been ticked, but we are still unable to obtain from Cheshire Highways Department any dates (either firm or otherwise) of when the work will commence. This frustration has led to a decision to write to the Chief Executive of the CW&C to request some form of intervention as, quite frankly, the lack of information and action from Highways is unacceptable. At the November Parish Council Meeting it was agreed that I would make everyone aware of this in this Newsletter and that I would also ask for your help. Please write or e-mail Highways Department to request action on this matter, as a matter of urgency. Let us see if we can make our displeasure known as a community and get this moved forward!

The Tiverton Act of Remembrance

The Tiverton Act of Remembrance was held as usual this year at 11am on the 11th November by the War Memorial on Huxley Lane, close to the Methodist

Chapel. Because of the Covid-19 restrictions it had been necessary to submit a Risk Assessment to CW&C to obtain approval to run the event. The rules for approval became even stricter as we moved from Level 2 to a full national lockdown. So, to comply, there could be no singing of hymns and no post ceremony refreshments and, of course, plenty of social distancing. I was also instructed not to advertise the event so as not to be seen to be encouraging people to attend. In the absence of a Minister from the Methodist Chapel Ann Wright led the service and the bugler Ted Fowles played the Last Post and then the Reveille, following the placing of the wreath and the 2-minutes silence. Although the whole ceremony was much briefer than normal it was appreciated by all those who attended.

Many people will be sad that the annual Carol Service will no longer be held there as it was, along with the Remembrance Day Service, one of the key events that brought the village together.
